## Certificate in Clinical Supervision-short course



This Certificate will recognise the skills and knowledge required to initiate, prepare for and participate in a structured process of clinical supervision.

This course applies to:

- workers who operate with significant autonomy in clinical professional service roles in A Clinical Setting either in the Healthcare or Allied Health Industry .
- workplace supervisors or other work colleagues who work under limited supervision and who have responsibility for mentoring one or more individuals in the workplace. This may include, but is not limited to, those who mentor an apprentice or trainee employed by, or undertaking a work placement within, an organisation.

It describes the skills and knowledge required to conduct individual and group instruction, demonstrate work skills and assess the success of training and one's own training performance, using existing learning resources in a safe and comfortable learning environment.

It emphasises the training as being driven by the work process and context, and applies to a person working under supervision as a work skill instructor in a wide range of settings. Lear

### WHO CAN APPLY?

Anyone who works within a healthcare industry setting who is either currently working as a supervisor or will be completing supervisory, mentoring or coaching duties within their role such as:

## **RECOGNITION OF PRIOR LEARNING**

Recognition of Prior Learning (RPL) is a key component of our courses. If you believe you are already in a supervisory role within a health setting workplace, you may be eligible to have your skills and knowledge recognised in a formal manner.

#### WHAT DO YOU HAVE TO DO?

The RPL process is simple.

- 1. Apply for RPL through the formal channel by sending an email to info@aihe.edu.au
- 2. Complete the form sent to you. (Note, you may be asked to provider workplace documentation to prove your experience. If this is not sufficient, you may be asked to complete some questions or assessments as part of recognising your experience).
- 3. Send in certified copies of original qualifications.
- 4. Have a discussion with a qualified AIHE Assessor.
- 5. If you tick all the criteria, then your experience and qualifications will be recognised with a formal email and you will received a certificate appropriate to the level.
